

COM 320 Final Project I Guidelines and Rubric

Overview

For the final project, you will take the role of a communications consultant preparing for an interview. The final project will consist of two components: a **media analysis and recommendations** (Final Project I), in which you will make recommendations to media makers about how to adjust your messaging to reflect cultural competence, and a **professional reflection** (Final Project II), in which you will consider how your own views about intercultural communication have developed throughout the course. This document contains the prompt, guidelines, and rubric for **Final Project I**.

Today's communication professionals are interacting with a wide range of audiences far beyond geographical boundaries. Advances in technology and globalization, along with the proliferation of mass media, are altering communication behaviors and processes. Therefore, understanding the interdependent relationship between media, technology, communication, and culture, and having the skills to work in multicultural contexts and interact within multicultural environments, are important professional qualifications.

Imagine that you are a communications consultant preparing for an interview. The organization you will be meeting with is seeking your assistance to review its past communications and provide recommendations on how to adjust its messaging to reflect cultural competence. Ahead of your interview, the organization asks you to share some of your past consultations with media organizations and the recommendations you provided.

In the first component of your final project, you will compile a collection of recommendations that you would make to the creators of three media stories to help you discuss the benefits of hiring you as a consultant.

Final Project I is divided into **two milestones**, which will be submitted in **Modules Two** and **Four** to scaffold learning and ensure a quality final submission. The final product will be submitted in **Module Seven**.

In this assignment, you will demonstrate your mastery of the following course outcomes:

- Apply concepts of ethnorelativism and cultural competency for the interpretation of multimedia communication
- Analyze bias in media systems and ethical challenges faced by media makers for responding ethically to one's own potential biases while creating media
- Evaluate news stories for how they have been positively and negatively impacted by globalization

Prompt

Choose three of the media examples that you have written about during this course, including one news media example. For each example, prepare an analysis and recommendations that you would share with the creators for making future news stories that reflect ethical and culturally competent communications.

Specifically, the following **critical elements** must be addressed:



- I. **Media Recommendations**: Choose two media examples from different categories. (Do not choose a news media example, as you will use one for critical element II.) Prepare a separate analysis for each example that deconstructs and examines the cultural values, stereotypes, and generalizations found in the news story, and conclude each of your analyses with a recommendation for changes that might be made in the creation of future news stories.
 - A. Compare the values depicted in the news story to the **cultural values** held by the society in which the message was created, providing relevant examples from the news story to support your claim.
 - B. Compare the stereotypes and generalizations depicted by the news story to those that occur within the **society** in which they were created, providing relevant examples from the news story to support your claims.
 - C. Compare the stereotypes and generalizations depicted by the news story to those that occur within a **contrasting culture**, providing relevant examples from the news story to support your claims.
 - D. Evaluate the impact of news stories in the context of a globalized world.
 - 1. Illustrate potential **positive consequences** of news stories with a global reach, providing examples to support your claims.
 - 2. Illustrate potential negative consequences of news stories with a global reach, providing examples to support your claims. E.
 - E. Make a recommendation about an approach to future media making for each of the creators in the media examples you chose.
 - 1. How might the media makers account for the **contrasting values** of multiple cultures, and the challenges of successfully communicating with all of them?
 - 2. How might the media makers ethically account for globalization in future communications?
- II. **News Media Analysis**: Choose a news media example. Analyze the news media example you chose for media bias in news coverage, and provide a recommendation for future news coverage.
 - A. Describe how the media produced by this news outlet **compares** with other news outlet within same country.
 - B. Compare the news coverage of the **media system** to which this news outlet belongs to the news coverage of a media system in a different country.
 - C. Compare the way this news story is covered by the news outlet to how the news story is covered by another news outlet within the same media system. Are there **differences** in how this particular news story is covered?
 - D. Assess the **news coverage** for the country where the news media story was created, providing evidence to support your claims. In other words, is the news coverage for this country accurate, varied, and balanced, covering both the positive and negative sides of the people, the culture, and the country as a whole?
 - E. **Recommend** an approach to the creators of this news media example for ensuring ethical newsgathering and news coverage. Be sure to discuss best practices for media professionals regarding awareness of one's own personal values.

Milestones

Final Project I Milestone One: Examples of Culture in the Media

In **Module Two**, you will choose two media examples from different categories. You will then prepare a separate analysis for each example that deconstructs and examines the cultural values, stereotypes, and generalizations found in the news story. **This milestone will be graded with the Final Project I Milestone One Rubric.**



Final Project I Milestone Two: News Media Analysis

In **Module Four**, you will analyze a news media example for media bias in its news coverage. In Module Three, you will begin working on this milestone by identifying a developing or prominent story to use for your news media coverage analysis. To complete this milestone, you will report on what you found by drafting your analysis. **This milestone will be graded with the Final Project I Milestone Two Rubric.**

<u>Final Project I Submission</u>: *Media Analysis and Recommendations*

In **Module Seven**, you will submit your final project. It should be a complete, polished artifact containing **all** of the critical elements of the final product. It should reflect the incorporation of feedback gained throughout the course. **This submission will be graded with the Final Project I Rubric.**

Guidelines for Submission: Your media analysis and recommendations should be a 5- to 7-page Microsoft Word document, double spaced, with 12-point Times New Roman font and one-inch margins. Cite your supporting sources in APA style.
